Queen of Hearts

THE GAME BOARD WILL CONSIST OF 52 CARDS PLUS 2 JOKERS. ALL CARDS ARE RANDOMLY PLACED FACE DOWN, NUMBERED AND SEALED WITHIN THE BOARD. BOARD IS CREATED WITH A BRAND-NEW DECK OF CARDS. A COMMITTEE OF 2 ILEAS & 2 SJRF BOARD MEMBERS, 2 ROCH EMPLOYEES & 2 MEMBERS OF THE COMMUNITY TO WITNESS THAT THE CARD PLACEMENTS ARE UNKNOWN. TICKETS WILL BE SOLD AND PLACED IN A TUMBLER FOR THE DRAWING.

ALL INDIVIDUAL PLAYERS MUST BE 21 YEARS OF AGE OR OLDER.

PLAYING THE GAME:

- ♥ All prize money payouts will determine by the staged amount in the Jackpot.
- ♥ Only one name per ticket.
- ♥ Tickets are \$5.00 each with no limit on purchase.
- ♥ Must be 21 years of age or older to participate.
- ♥ Tickets will be sold starting at noon the day following the drawing until 15 minutes before the next drawing.
- ♥ Drawing dates are every Wednesday @ 7pm at Roch's Place, 101 N. Main Street, St. Joseph, IL 61873.
- ♥ The winning ticket will be drawn by a representative of Roch's Place, the ILEAS Foundation or the St. Joseph Recreation Foundation and will be paid a designated specified amount.
- ♥ The holder of the winning ticket will have three (3) minutes from the time of winning ticket announcement to identify themselves and choose a card number on the game board.
- ♥ When the holder of the winning ticket finds the Queen of Hearts, they will receive 50% of the jackpot, **if and only if the winner is present on site**. 10% will go to THE ILEAS Foundation, 30% to SJRF and 10% will roll to the next board jackpot.
- ♥ When the holder of the winning ticket **is present on site**, and your number selection is a JOKER, ACE, KING, TEN, or DEUCE, you will receive **100%** of the listed designated specific winnings and **100%** of the amount awarded for being a ticket winner.
- ♥ When the 2nd Joker is turned over the game will restart the game board, and a new deck will begin the following week. **100%** of the advertised jackpot rolls over to the new game.
- ♥ When you know you cannot be present at the drawing, you can write down an existing numbered card from the board on your ticket and the representative will select and open your designated numbered card. If you have not placed a numbered card on your ticket, we will attempt to contact you with the phone number provided on the ticket. If we are unable to contact you, the first card available on the board will be selected on your behalf.
- ♥ If you **are not present on site**, and your number selection is the Queen of Hearts, you will receive **30%** of the jackpot. 10% will go to the ILEAS Foundation, 45% will go to SJRF and 15% will roll to the next board jackpot.

- ♥ If you **are not present on site**, and your number selection is a JOKER, ACE, KING, TEN, or DUECE, you will receive **50%** of the listed designated specific winnings, and **50%** of the amount awarded for being a ticket winner. The remainder stays in the jackpot.
- ♥ When the Queen of Hearts is **NOT DRAWN**, the jackpot will roll over into the next weeks drawing all previous tickets are destroyed, and new ticket sales will begin.
- ♥ All Queen of Hearts winners are required to complete a W-9 form. This form must be completed and returned to SJRF before a winner receives their winnings. Any winner of \$600.00 or more will have their actual winning amount reported to the IRS.
- ♥ All rules are set with the final decisions made by the ILEAS Foundation.

By purchasing a ticket and choosing to participate in the Queen of Hearts raffle, each Queen of Hearts raffle participant acknowledges and agrees that Illinois Law Enforcement Alarm System Foundation (ILEAS) and St. Joseph Recreation Foundation (SJRF) have the right, in their sole discretion, to elect not to proceed with the Queen of Hearts raffle for any reason whatsoever or for no reason. In such an event ILEAS and SJRF will conduct one final drawing in which tickets will be drawn until the Queen of Hearts location is determined on the board.

The Queen of Hearts raffle is subject to these terms and conditions. These terms and conditions cannot be changed by any oral statement made by any employee, consultant or agent acting on behalf of ILEAS and SJRF. By participating in the Queen of Hearts raffle, participants accept and agree: (1) to be bound by these terms and conditions and the decisions of ILEAS and SJRF, which shall be final and binding; (2) waive any right to claim ambiguity in the Queen of Hearts raffle or these terms and conditions; (3) that ILEAS and SJRF may use any participant's name, photograph, likeness, statements, or voice for promotional or advertising purposes in connection with the Queen of Hearts raffle in all forms of media, now or hereafter known, in perpetuity, without review, permission or further compensation, except where prohibited by law.

By participating in the Queen of Hearts raffle, each participant releases ILEAS, SJRF, Roch's Place, their respective directors, officers, employees, their affiliates, and all of their agents and volunteers ("Released Parties") from any and all liability injuries, losses or damages of any kind (including without limitation, attorney's fees) caused by participating in the Queen of Hearts raffle or winning any prize or resulting acceptance, possession, use or misuse of any prize and each participant and/or winner agrees to indemnify and hold harmless Released Parties from any and all losses, damages, rights, claims and actions of any kind arising from, in connection with, or as a result of participating in the Queen of Hearts raffle or any winner's acceptance or use of any prize. A Queen of Hearts raffle shall be limited to the return of the purchase price paid for their ticket(s). In no event shall Released Parties be liable to any party for any loss or injuries to earnings, profits, or goodwill, or for any incidental, special, punitive or consequential damages of any person or entity whether arising in contract, tort or otherwise, even if advised of the possibility of such damages, any controversy or claim arising out of or relating to the Queen of Hearts raffle or these terms and conditions shall be settled by binding arbitration administered by the American Arbitration Association (pursuant to its expedited procedures) under its commercial arbitration rules and conducted in Champaign County, Illinois. Judgement on the award rendered by the arbitrator may be entered in any court having jurisdiction thereof.
